美國

美國就業服務工作肇始於十九世紀末葉,至1933年美國國會通過華格納.皮塞法案後(Wagner-Reyser Act)乃正式建制。1933年於勞工部之下設置就業安全局,主管就業服務與失業保險。1942年成立戰時人力委員會,就業服務工作劃入該委員會主管。1949年又恢復就業安全局。1973年就業安全局擴大業務範圍,改制為人力署。近年來聯邦政府感於該業務範圍廣泛,遂改制為就業服務與職業訓練署(The Employment and Training Administration)。其相關法律包括:
