英美職業訓練法簡介

英國

英國職業訓練的起源甚早,遠在中古時期,各種工商行會 (Guild)就已開始推 動實施學徒訓練制度,其後雖然迭受時代演進,社會變遷、經濟轉型等的長期影響 ,但是此種制度一直屹立存在,並且不斷隨著調整改進,其演進的過程,大抵可以 分爲三個階段。第一階段,中古時期至1964年,此一階段的職業訓練不受政府法規 約束,而由各工商行會及企業單位自行辦理。第二階段,自1964年至1983年,英國 政府於1964年3月頒行「工業訓練法 | (Industrial Training Act), 並著手規劃建立 全國性的工業訓練體制。依照該法所賦予的權責,「勞工部」開始督導各行業設立 「工業訓練理事會」(Industrial Training Board),並將職業訓練工作的辦理主體, 由工商行會及企業單位轉移至工業訓練理事會,舉凡訓練合約的訂定、訓練課程的 提供、訓練經費的補助、結訓證書的頒發等,均責由該理事會做妥善的安排。1973 年英國政府重新頒訂「就業與訓練法」(Employment and training act),將職業訓 練的中央主管機關,由原來的勞工部改爲「就業部」,以加強職業訓練與就業服務 的相互配合;又在1974年於就業部下設立「人力服務委員會 | ,(Manpower Services Commission),以研究、制訂並推動全國的人力發展政策及職業訓練措施; 同時由政府編列經費預算,來補助各行業的工業訓練理事會,以加強輔助企業單位 辦理訓練。第三階段,自1983年迄今,英國政府於1983年宣布解散大部分的工業訓 練理事會,而將企業訓練工作轉由企業界自行規劃辦理,政府不再加以干預。
